### PLEASE READ CAREFULLY, SIGN AND RETURN

In consideration of the opportunity to participate in the Corona Eagles FC ("CEFC") 3v3 Tournament and other events and activities related to my participation (collectively, the "Tournament"), I, the undersigned, acknowledge and agree that:

1 Participation in or attendance at the Tournament involves inherent risks and dangers of accidents, personal and bodily injury (including death) and property loss or damage. These may result from my own actions or inactions, as well as the actions or inactions of others, the rules of play, and the condition of the facilities and equipment. Further, there may be other risks not known to me and not reasonably foreseeable at this time. I have considered the nature and extent of the risks involved and I voluntarily choose to assume all such risks, known and unknown, even those risks that result from the negligence of the Released Parties (defined below) or others and assume full responsibility for my participation in the Events. I consent to treatment in the event of an emergency or other incident in which, in the reasonable judgment of the on-site personnel, I require medical care.

2 I understand that the Tournament may be photographed, videotaped, or otherwise recorded, and I agree that CEFC may use my name and likeness (in any form and without regard to distortions of character, form or color, or any other alteration) in photographs, videotapes, audiotapes, and other media, without any additional consideration to me or to any third party.

3 I, for myself and on behalf of my heirs, estate, insurers, successors and assigns, hereby release, indemnify and hold harmless CEFC, and their affiliates, officers, directors, shareholders, employees, agents, volunteers, and representatives, and the successors, assigns, and insurers of such entities, and any consultants, sponsors, advertisers, owners or lessors of premises used in connection with the Tournament, (collectively, the "Released Parties"), with respect to any and all claims or causes of action I may have for damages for personal or bodily injury, disability, death, loss or damage to person or property, whether arising from the negligence of any or all of the Released Parties or otherwise, to the fullest extent permitted by law.

I have read this Release of Liability and Assumption of Risk Agreement, fully understand its terms and understand that I am giving up substantial rights by signing it. I sign this Release of Liability and Assumption of Risk Agreement freely and voluntarily, without any inducement or coercion.
